Datuk Tan Kok Liang, President of FATA and President of MATTA

Tan Kok Liang is the current President of the Malaysian Association of Tour and Travel Agents (MATTA) as well as the President of FATA. He is a Chartered Accountant by training, and due to his passion in travel, he further pursued his studies and obtained a Masters in Tourism from the University of Toulouse, France.

As MATTA president, Tan has instituted several key initiatives to further drive inbound tourism to Malaysia such as setting up the Malaysia-based on-line booking engine to ensure members' business interests are protected and initiating aggressive overseas promotions to China, India, UK, Europe and ASEAN. During this pandemic which subsequently led to the closing of the border, Tan has been lobbying the Malaysian government to reassess for gradual easing of the border to international tourists, especially when Malaysia entered the recovery phase of the Movement Control Order in June, and the numbers of new Covid-19 cases were in single and double digits.

He is the owner and director of Borneo Trails Tours & Travel, a leading inbound tour operator based in Sabah which has won numerous awards and recognition from Tourism Malaysia and Sabah Tourism.

He also operates an eco-lodge in Sabah known as Borneo Nature Lodge. In 2018, he was the award recipient of Tourism Promotion Organisation (TPO) Best Award – Best Tourism Industry Leader, in recognition of his valuable contribution to the development of the tourism industry in the Asia Pacific region. The award was conferred by Tourism Promotion Organization for Asia Pacific Cities, an international organization established in 2002 with the blessing of the 5th Asian-Pacific City Summit.

After the success of the company, CSL Travel & Tours expanded its business and became an accredited IATA agent since 2011.

Seeing the ever-increasing opportunity in the tourism industry in Cambodia, Mrs. Chhay Sivlin founded CSL Group Co., Ltd. in 2009, while in the same year, she had begun her venture into the hospitality sector by establishing a four-star hotel, Kingdom Angkor Hotel, in Siem Reap Province. The hotel and travel agency were both added to CSL Group Co., Ltd under the same umbrella. As the local tourism industry was booming, and both companies kept performing better, Mrs. Chhay Sivlin realized the need for an increased number of boutique hotels in Siem Reap; hence when Lynnaya Urban River Resort was born in 2014.

After years of gaining invaluable experiences through her businesses in both hospitality and travel industries and being one of the board members of Cambodia Association of Travel Agents (CATA), Mrs. Chhay had a vision to share those personal experiences to her fellow colleagues as well as new entrepreneurs within the industry, and that led her to get nominated to become the president of CATA.
