# ITB Asia 2020 – Buyers Packages

#### **Fully Hosted Buyer Package**

(Host air flight and accommodation)

For serious buyers only.

- 24 Business Appointments with Exhibitors
- Hosted Hotel Accommodation in 4/5\* Hotels
- Reimbursement of Air Passage into Singapore (only applicable to fully hosted buyers)
- Admission to Exhibition Hall on all 3 Show Days
- Admission to ITB Asia MICE and Corporate Hub
- Admission to Networking Functions
- Local Airport Transfers to and from Official Hotel provided or reimbursed based on SGD 50 capped amount
- Admission to Buyer's Lounge
- Registration Fee: USD 250 per delegate (Waived for referrals)

Deadline of Registration: 15th August 2020 (2359hrs, GMT+8)

# Note:

- ITB Asia will host 3 nights stay for buyers based in Asia, from 20<sup>th</sup> Oct 2020 onwards.
- ITB Asia will host 4 nights stay for buyers based outside of Asia, from 20<sup>th</sup> Oct 2020 onwards. (including Australia and New Zealand)
- Complimentary airport transfer will be provided to only Fully Hosted Buyers

# **Hosting Criteria for ITB Asia 2020:**

- 1. Commit to a set number of appointments with ITB Asia exhibitors based on selected buyer's package
- 2. <u>Decision maker</u> of a company whom had significant procurement volume of travel services such as accommodation, air tickets, tour packages, etc. For example: travel agents, corporate & outbound travel managers or travel procurement managers
- 3. Noticeable procurement track record in Asia (ITB Asia may conduct checks on proof of travel procurement for auditing purposes)



- 4. ITB Asia will not accept profiles that are sales/ business development related unless applicants are able to provide proof of procurement.
- 5. In most cases, ITB Asia would only accept <u>1</u> hosted outbound travel manager/agent per company. He/she would have to hold regional procurement track record i.e. APAC Travel Manager, instead of national title such as Travel Manager India.

# **ITB Asia Buyer's Application Procedure:**

# Step 1: Recommendation/ Invitation

- Send list of recommended buyers to ITB Asia
- ITB Asia would recommended buyers on behalf and manage all enquiries
- Recommend buyers to register online with recommendation code. Registration link and recommendation code would be provided in March.

# Step 2: Buyer's Registration

- ITB Asia would update partner on the registrant list weekly. (i.e. completed/incomplete registration, pending/ submitted agreement form)
- Deadline of registration for buyer: <u>15<sup>th</sup> August 2020</u>

### Step 3: Validation

- ITB Asia will only validate all <u>completed</u> registrations
- Buyers will receive the approved/rejected auto-generated email upon validation
- Approve/Rejected status will be reflected in individual buyer's login
- Validation will commence from June 2020 onwards

# Step 4: Submission of Agreement Form (after receiving the "Approved" email by ITB Asia)

- Agreement form A contractual agreement between ITB Asia and respective buyer on terms of hosting and reimbursement amount
- Buyers in agreement with the terms of hosting would confirm their participation by submitting their agreement form
- Only buyers whom submitted agreement forms are confirmed buyers
- Kindly note that a fee of USD 1 will be charged to all hosted buyer applications to verify the validity of buyers' credit card details

# Step 5: Pre-scheduled appointment (PSA)

- Buyers whom had submitted the agreement form would be invited to pre-select potential exhibitors based on industry and area of focus
- Upon selection, ITB Asia would proceed with the appointment matching algorithm and a schedule of appointments will be auto-generated to all confirmed buyers



Step 6: Online Diary

• Buyers may login their account to manage appointments or add more appointments to their calendar

Step 7: Attend ITB Asia 2020 from 21 –23Oct 2020

• Attend ITB Asia 2020 and complete all scheduled appointments
